

Training Course Endorsement Scheme Information for Course Providers

Section 1: Benefits of endorsement

- 1. The use of the Society of Dairy Technology endorsed training logo (as above) on your course materials, advertising and website.
- 2. The use of the Society of Dairy Technology logo and words to indicate 'approved by' on your certificates and course materials, advertising and website.
- 3. Your course listed on the Society of Dairy Technology (SDT) website with a link to your own website and registration forms.
- 4. A listing on the Events Calendar in the monthly SDT newsletter (distributed to around 500 recipients) if details are supplied with sufficient time before the copy deadline of the nearest issue.
- 5. Course objectives and outcomes will be evaluated through the application process and therefore resulting approval for training will provide credibility within the dairy industry because the outcomes and objectives must be relevant to the dairy industry.
- 6. 15% discount on placing your own advertisement for the course in the newsletter.

Section 2: How does the Scheme work?

There are THREE activities to register with the SDT:

- 1. The Centre
- 2. The Trainer
- 3. The Course

To apply, please complete the attached application form and return it to the Executive Director of the SDT using the email address below. Ideally you should allow 2-3 months until the first date that the course is running. We will assess your application at our quarterly Council meetings (held in February, May, August and November) and will usually give a decision within 14 days.

Endorsement is valid for 3 years, subject to receipt of satisfactory feedback from delegates. All courses must be submitted for re-endorsement after 3 years.

When a previously endorsed course is repeated the following conditions apply:



- ➤ When there is a change within this period in the personnel delivering the course, or when improvements to the content are made specifically in response to feedback from delegates, details should be submitted to the Society.
- ➤ When the course content is changed by more than 25%, for any reason, a new application needs to be submitted.

Section 3: Criteria for endorsement

To be endorsed a course must satisfy the criteria below:

- 1. Centre Director is a member of the SDT. (Trainers registration reduction if member)
- 2. The course should have clearly defined objectives and be well-targeted at the intended audience in terms of subject content and course delivery.
- 3. Course trainers should have suitable qualifications and experience related to the dairy industry. Experience is measured at 5 years in the dairy industry as a minimum. This can be aggregated.
- 4. Course materials (hard or soft copy) should be provided and any materials should be well-matched to the course content and objectives.
- 5. Feedback from course delegates must be collected (see application form for details). We will provide a standard Society of Dairy Technology delegate feedback form and would prefer this to be used. After each course, delegate feedback forms must be collected and sent to us with a completed summary sheet within one month (approx) of the course.
- 6. Centre has a written quality statement displayed on its website or office location indicating its commitment to good quality training and delivery within dairy related topics.
- 7. The Centre¹, securely² within GDPR rules, keeps:
 - a) Centre details
 - b) Candidate details
 - c) Course registrations using a templated register which may be uploaded to SDT
 - d) Maintains a register of certificate numbers
- 8. Centre has a QA manual reviewed every 3 years.
- 9. The Centre must maintain a register of all SDT registered trainers.
- 10. The Centre must maintain a register of all training activity that is 'approved by the SDT'.
- 11. The Centre secures and delivers examinations prior to delivery.
- 12. Centre trainers attend 1 annual CPD (SDT Symposiums).
- 13. Each candidate must complete a one-page feedback (Centre derived or SDT)
- 14. Centres must allow access by a member of SDT for audit.
- 15. Maintain 3 yearly inspections by SDT staff audit action list.
- 16. Ensure trainers have a training Accredited (OFQUAL) qualification to level 3.

¹ Centre: Means the business

² Securely: means in a lockable storage or filing cabinet and when on a computer/cloud secures all data on these electronic means with a password.
